
Investment objectives of the fund

The fund's objective is to deliver capital growth over the long term by investing primarily in exchange traded products and tracker funds to gain exposure to the investment market. To achieve this it follows an adventurous strategy, with a large exposure to shares, including overseas markets like emerging markets and Asia and potentially including exposure to smaller companies. Unlike the Maximum Growth model, around a quarter of the portfolio is diversified across non-equity investments, primarily bonds. The bias towards shares can mean a higher chance of short-term volatility, and there are separate risks when investing in smaller companies and overseas markets.

Cumulative performance (%)

Cumulative performance can be useful as an indication as to what an investment has or would have achieved for you in real terms over a period and represents the funds overall long-term performance. The performance data is sourced from Morningstar and covers the period 07 January 2022 to 31 March 2024. It is the total return (return inclusive of interest, capital gains, dividends, and distributions), it does not include the impact of tax but does include the impact of the OCF.




